

COOKIES POLICY

BACKGROUND

This Policy applies as between you, the User of this Website and 360Capital Ltd, the owner and provider of this Website.

1. DEFINITIONS AND INTERPRETATION

In this Policy the following terms shall have the following meanings:

"Data" means collectively all information that you submit to the 360Capital Ltd via the Website. This definition shall, where applicable, incorporate the definitions provided in the Data Protection Act 1998;

"Cookie" means a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in Clause 12;
